

Deviated Fixed Route

Rio Metro Route 210 is a Deviated Fixed Route bus service. This means that the bus operates along a fixed route and keeps to a timetable, but passengers can request to be picked up or dropped off up to one quarter (1/4) of a mile off of the bus route. After deviating from the route, the bus returns to the same point it deviated from to continue its run. The pickup and drop off locations will be at the curb. Deviated Fixed Routes are open to the **general public** and person(s) with or without disabilities. One deviation per run up to 1/4 mile off the route will be provided and trips will be scheduled on a first-come, first-served basis. Passengers must call the Rio Metro Dispatch Office at 505-352-3595 to request this service the day before service is desired by 12:00 p.m.

Desviado Ruta Fijas

Río Metro ruta 210 es un servicio de autobús de ruta fija se desvió. Esto significa que el bus funciona a lo largo de una ruta fija y mantiene un horario, pero pasajeros pueden solicitar ser recogido o dejados hasta un cuarto (1/4) de milla de la ruta del autobús. Después de la desviación de la ruta, el autobús se devuelve al mismo punto se desvió de continuar su recorrido. La recogida y devolución de localidades será en la acera. Desviado rutas fijas están abiertas al **público en general** y personas con y sin discapacidad. Una desviación por ejecutar hasta 1/4 de milla de la ruta será proporcionado y viajes se programarán en orden de llegada. Pasajeros deben llamar a la oficina de despacho Río Metro en 505-352-3595 para solicitar este servicio el día antes de que se desea servicio de 12:00 p.m.
